

SUBMISSION RELEASE FORM

I, the undersigned, wish to submit/ narrate/ screen the material (“Material”), which is an original script / screenplay /story / lyrics or any other work namely _____ to Dream Warrior Pictures (“DWP”) and/or Potential Studios LLP (“Potential”). I agree, understand and confirm that the Materials are accepted for submission on the following Terms and conditions:

- i. I have registered my script/synopsis/screenplay with the concerned Writers’ Union or Screen Writers’ Association prior to submission of the said Material.
- ii. I request DWP and/or Potential to review and evaluate the Material to decide whether DWP and/or Potential will undertake efforts to acquire all or parts of the said Material. I shall not be entitled to any compensation from DWP and/or Potential for this submission.
- iii. I have retained at least one copy of the Material, and I release DWP and/or Potential from any and all liability for loss or other damage to the copy of the Material submitted hereunder. I agree that DWP shall have the right to review and confirm the Material (whether in whole or in part) or reject the Material within a period of 90 (Ninety) days from the date of submission of the Material with DWP and/or Potential. Upon such review, DWP and/or Potential shall intimate me regarding the confirmation or rejection in writing. Upon intimation of rejection, I hereby agree that the Material will be discarded if I fail to retrieve it within 15 (Fifteen) days of receipt of the intimation. I understand and agree that incase I fail to receive any intimation from DWP and/or Potential within the 90 days, it will be deemed to have been rejected and DWP and/or Potential shall not be obligated to notify me of such rejection or to return the Material to me if I fail to retrieve it within 15 days thereon.
- iv. I absolve DWP and/or Potential of any liability for any loss, theft or destruction of such copy when in its possession or in transit.
- v. I acknowledge that no confidential relationship is established between DWP and/or Potential and me by reason of this submission.
- vi. I acknowledge that DWP and Potential are a prominent and a well reputed production company in the entertainment industry and DWP and/or Potential /its associates/employees constantly create(s), receive(s) and develop(s) or otherwise acquire(s) material or elements, that may be similar or identical to the Material. I recognize that the Materials which DWP and/or Potential may use in the future may have originated or may have been acquired from its own employees or others and may duplicate or resemble elements of the Material. In the event there are any similarities or elements of similarities to such other materials submitted to or developed by DWP and/or Potential, I shall not be entitled to any compensation from DWP and/or Potential /its associates/employees and/or I shall not seek to enforce any legal or other right or action against DWP and/or Potential /its associates/employees in relation to the Material.
- vii. I respect DWP and and/or Potential’s concern that any examination of the Material without a full release of liability might expose DWP and/or Potential to a claim of plagiarism or some other claim or threat of litigation.
- viii. I represent and warrant that (i) I am the author of the said Material and the sole copyright owner of the Material and all elements thereof and the Material does not violate the rights of any third party.
- ix. I hereby agree to defend, indemnify and hold harmless DWP and/or Potential (and its associates, officers, directors, employees and representatives) against and for any and all claims, liabilities, damages, costs and expenses arising from or related to the Material, including the use thereof by DWP and/or Potential, or any breach of any undertakings, representations or warranties and obligations given by me herein.
- x. I further agree that no other obligations exist or shall exist or be deemed to exist unless and until a formal written agreement has been entered into by and between DWP and/or Potential and me, and the rights and obligations of each of DWP and/or Potential and me shall be expressed in said formal written agreement.
- xi. The courts in Chennai shall have exclusive jurisdiction over any disputes arising hereunder. This Agreement shall be governed by and construed in accordance with the laws of India.
- xii. If any provision of this form is adjudged by a court to be void or unenforceable, the same shall in no way affect any other provision of this letter, or its validity or enforceability, and the unenforceable provision shall be performed to the extent valid and enforceable.
